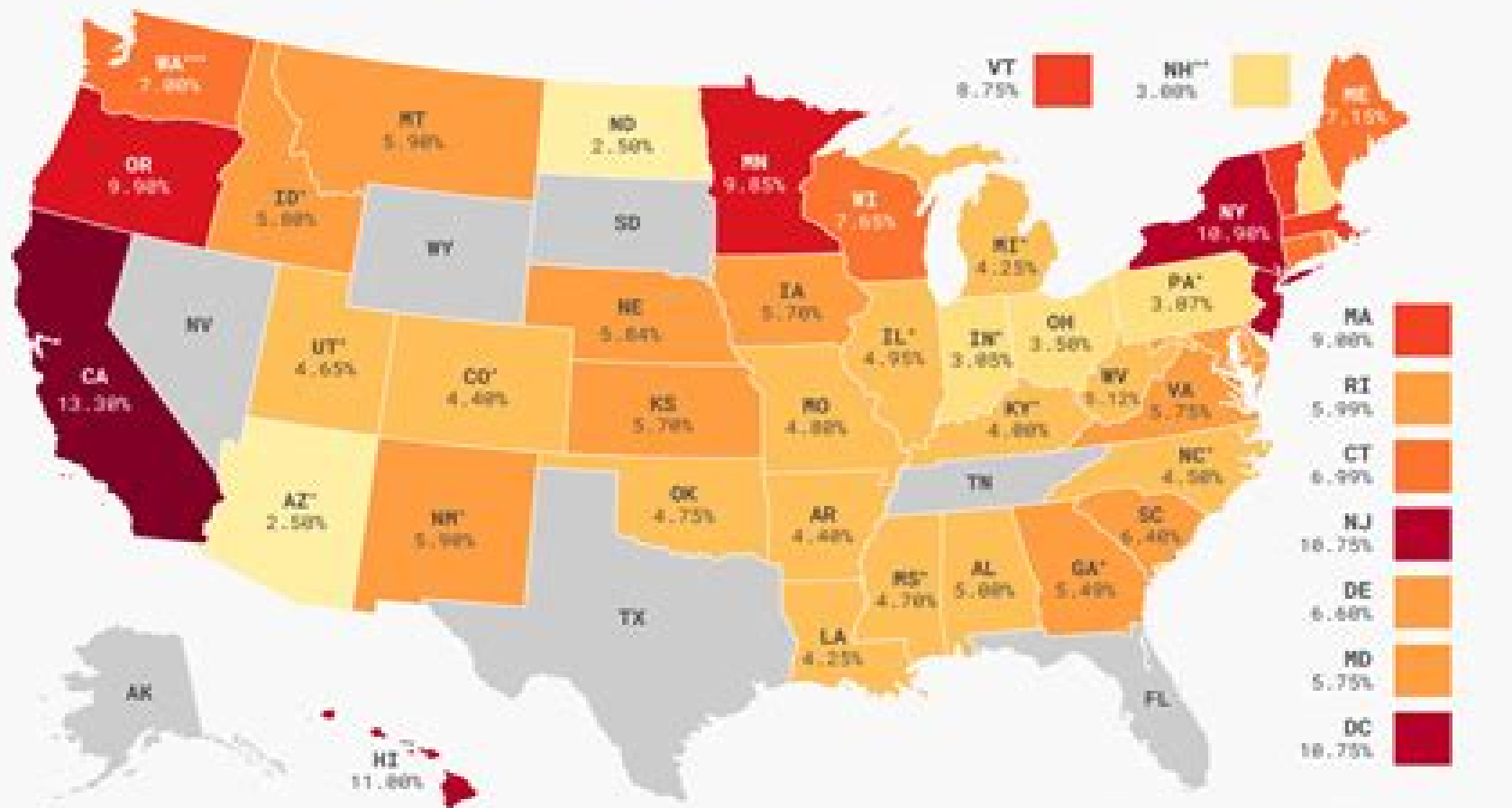


# Top Marginal State Individual Income Tax Rates (as of January 1, 2024)
