Field Sobriety Test Instructions HGN

1. I am going to check your eyes.
2. Keep your feet together, hands by your sides.
3. Keep your head still and follow the stimulus with your eyes only.
4. Do not move your head.
5. Do you understand?

One-leg Stand (30 seconds test)

1. Stand with your feet together and arms by your sides. (Demonstrate).
2. Do not begin the test until instructed.
3. When I tell you to, raise one leg, either leg, approx. 6" off the ground, foot pointed out. Keep both legs straight, don't bend your knees. Keep your eyes on your raised foot.
4. While holding that position, count out loud; one thousand one, 1002, 1003, & so on until you are told to stop. (Demonstrate).
5. Do you understand? You may begin.

→ line and put your right foot forward with your right heel touching the ground. Keep your hands at your sides.

If I tell you to. take nine heel-to-toe steps, turn around keeping your balance. I will demonstrate, how to do these steps.

Stand on one foot. Put your front foot on the ground by taking several steps with your other foot. (Demonstrate).

For the one-leg stand test, watch your balance. Count out loud, don't stop counting until I tell you to stop the test. You may begin.
