### CORE BOARD RESPONSIBILITIES

#### FULFILL THE MISSION

A nonprofit board is obligated to make sure the organization follows its stated mission. This is something the IRS actually cares about!

#### SET POLICY

A nonprofit board uses policies to set boundaries for the Executive Director to do the work. They don't (usually) do the work themselves.

#### OVERSEE THE FINANCES

Nonprofit boards set budgets and keep an eye on finances. This protects the organization and protects the board

#### PLANNING

Boards should look into the future. What exciting opportunities are coming? Are there any new threats? Boards are very good for this kind of work.

#### FUNDRAISING

Boards are part of fundraising. This might mean stuffing envelopes, filling a table at a gala, and connecting the ED with donors they know.

#### HIRE/FIRE THE ED

The board as a whole is responsible to hire, evaluate, and (in dire cases) fire the ED. One note: individual board members aren't ED supervisors!

#### IMPROVE ITSELF

A board should improve itself. Find great new board members to replace those leaving. Attend trainings. Build skills. It's essential work.
