Appointees in Orange, Dutchess and Putnam Counties receive \$1,646 in annual location pay. An annual uniform allowance is also provided.

NYS Court Officer-Trainess are beace officers, required to wear uniforms, and may be authorized to carry finestries, execute bench warrants and make arrests. Typical duties include: guarding and escorting criminal defendants while in the court facility, especting judges, Lirios and witnesses; handling court documents and forms; providing information and assistance to the public and other court users: maintaining the security of deliberating and sequestered luries, displaying and safeguarding exhibits: operating security equipment and using established search procedures; physically restraining and coloning unruly individuals; administering first-aid and assistance to individuals during amergencies; and performing related outles.
