People accepted and waited for the next disaster as they had no alternatives. This book is based on an empirical study presenting a timeline analysis of major cyclones and their impacts and consequent losses through the super cyclones in the disaster prone coastal regions of India, Sri Lanka and Bangladesh. This study also investigates resilience mechanisms based on early warning systems, technology applications including GIS and remote sensing, best practices, success stories and case studies that can be used for effective cyclone management and development of a resilience mechanism among coastal communities.
