constitution of 1784 The 1980s and 1990s witnessed a series of clashes over court administration allegations of judicial corruption and finally a bitter and protracted battle over Court decisions on educational funding Chief Justice Brock publicly embodied the judicial branch's new status and assertiveness When information came to light regarding some of his administrative actions on the high court deepening antipathy toward him exploded into an impeachment crisis The struggle over Brock's conduct raised significant questions about the meaning and proper practice of impeachment itself as a feature of democratic governance When articles of impeachment were voted by the House of Representatives the state Senate faced the difficult task of establishing trial protocols that would balance the political and juridical responsibilities devolved on them simultaneously by the state constitution Having struck that balance the trial they conducted would finally acquit Brock of all charges Nevertheless David Brock's impeachment was a highly consequential ordeal that provided a needed catalyst for reforms intended to produce a productive recalibration of legislative judicial relations
