

Cristina Maria Cervone, Nicholas Watson, 2022-08-30 What Kind of a Thing Is a Middle English Lyric considers issues pertaining to a corpus of several hundred short poems written in Middle English between the twelfth and early fifteenth centuries The chapters draw on perspectives from varied disciplines including literary criticism musicology art history and cognitive science Since the early 1900s the poems have been categorized as lyrics the term now used for most

The Bible in Early English Literature David C. Fowler, 2018 In this companion to his previous book The Bible in Early English Literature
