entities provide the dealership the ability to clarify operations and distinguish activities If the return is a large consolidated operation flow through schedules or other accompanying statements are disclosed on the return identifying these activities New automobile dealerships maintain good internal controls and prepare complete books and records Dealerships as franchisees properly book sales activities to conform to the financial statement requirements imposed in the form of the manufacturers statements by the franchiser the factory Once the income is booked some dealerships may incorrectly treat or classify them for tax purposes This may occur through shifting of business activities to related entities An entity chart is helpful in visualizing the organizational structure It is important that all related returns are gathered One entity may own the land where the dealership operations are and rent is paid to the shareholder Another entity may be an insurance company formed to facilitate the paper flow of extended service contract sales or a management company is formed to receive management fees All three are related entities and related party transactions should be examined An understanding of each entity s activities business purpose and tax implications would be required
