where R_A = unlevered cost of capital, R_D = cost of debt, D = debt, V = value of firm

Example: $R_A = 10\%$, $R_D = 8\%$, $D/V = 0.4$, $R(R_A) = 10\% + (0.4)(8\% - 10\%) = 9.2\%$

WACC = $R(R_A) = 9.2\%$
