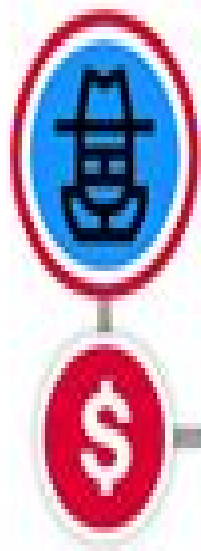

**Dirty money is acquired**



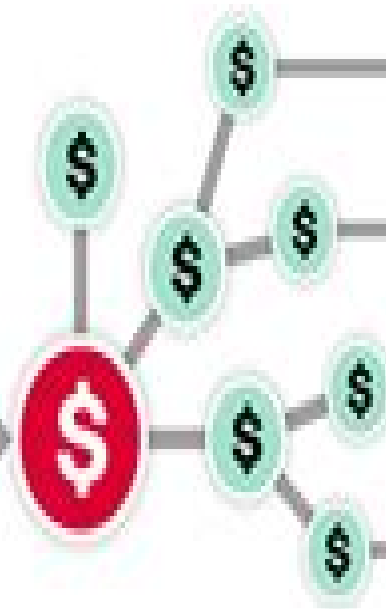
**Step 1: Placement**
