Insurance - contract by which one undertakes to indemnify another against loss, damage, or liability assing from a contingent event

Transfers risk from individual to a group

Risk - uncertainty about loss

Types of Risk

Pure risk - involves loss/no loss, no possible gain/profit, i.e. you wreck car or not --only type insurance companies will accept

Speculative risk - possible opportunity for loss/gain, i.e. lotto, real estate investment (don't use insurance to make a profit)

Risk Management Strategies: S(hanng), Transfer, Avoidance (not panticpanting), Reduce (is spainkless), Retain (self-insuring, has money to cover)

Peril - cause of a loss

Open peril - Special form/policy

Named peril - requires peril causing loss to be named in policy for insurer to pay the claim
