Separate chapters address other types of briefs and filing mechanics and the final chapters address oral argument and rehearing petitions. The appendix to this book includes complete copies of the principal briefs discussed along with several other documents on proper formatting and style. The contested mixture of law and technology, of democracy and progress, is a fortunate place to spend one's career. Law changes slowly, and much of the basic guidance for writing appeal briefs today is the same as it would have been when the patent laws were written hundreds of years ago. Technology, of course, moves quickly in comparison, and presenting relevant legal arguments requires staying current with complex factual changes. The aim with this 2018 Edition is to help all lawyers contribute to an effective presentation to the Federal Circuit, a presentation that advances the client's interests by working within the Supreme Court's and thus the Federal Circuit's expectations of sound appellate briefing.
