### **POINT OF CARE INR MANAGEMENT**

#### **POLICY**

The Family Health Team is committed to ensuring that all patients requiring anticoagulation therapy are managed in a timely, cost effective, and therapeutically appropriate manner that is accessible and acceptable to both patients and physicians.

Target therapeutic ranges are established using best practice guidelines.

Only Nurse Clinicians and Lab Technicians trained in the use of the Point of Care INR testing device are authorized to administer these tests.

The Clinical Pharmacist interprets and adjusts warfarin dosages as per medical directive.

#### **PROCEDURE**

1. Patient presents to the clinic as per scheduled time.
2. Lab Technician administers Point of Care test, records results on communication tool and passes tool to appointed Nurse Clinician.
3. If INR is between 2.2-2.8 for target therapeutic range of 2-3 or 2.7-3.3 for target therapeutic range of 2.5-3.5, the Nurse Clinician completes a brief history of client status, medication changes and adherence to treatment since last test date. The Nurse Clinician provides the patient with a card showing the date of the next INR measurement and documents in the EMR.
4. If INR is outside the parameters, the Nurse Clinician forwards the patient to the Clinical Pharmacist.
5. The Clinical Pharmacist assesses the patient and adjusts the warfarin dosage as per the approved treatment algorithm.
6. If a new prescription is needed, the Clinical Pharmacist generates the script for the responsible physician to sign and gives it to the patient. The Clinical Pharmacist documents in the EMR.
7. The Clinical Pharmacist provides the patient with a card showing the time for the next INR measurement.
8. The Clinical Pharmacist reviews INR report log at end of clinic and reports to physician as necessary.
