He thus applies cognitive linguistic tools to two considerations: first, whether Paul had contextual reasons to generate his innovation in 1 Corinthians 15; and second, whether Paul's innovation recurred or had continual effects in Christian groups. In so doing, Chang shows that Paul's innovation directly addressed a contextual issue of death rites in Corinth and exerted a continuing effect on Paul's later ideas of transformation, spirit possession, and baptism.
