 - ☐ The place where the defendant is confined, or, if not confined, the defendant's current address
 - ☐ The offenses for which the defendant was convicted and sentenced
 - ☐ The date on which the defendant was sentenced
 - ☐ Whether the defendant was convicted by a jury, by a judge without jury, or on a plea of guilty, guilty but mentally ill, or nolo contendere
