

Settlement Negotiations, Mediation, and/or Information Gathering

If your case is settled, you can submit the settlement to the judge to finalize 30 days after your case has been on file. If it appears that your case will not settle or if we need more information to decide, we may need to gather information and documents from your spouse using discovery. If you have an issue regarding custody, many courts will require you to attend mediation before your case can be set for trial. You can voluntarily attend mediation on any issue.

Some courts require that you attend a settlement conference a few weeks before your trial to present your information to a neutral judge and to receive recommendation on settlement terms.
