

# Motion for Relief from Judgment<sup>1</sup> Checklist

- ☐ (1). Is defendant challenging a circuit court conviction?
  - No. The court has no jurisdiction. Dismiss the MRJ. Go to (17).
  - Yes. The court has jurisdiction. Go to (2).
- ☐ (2). Is this defendant's first MRJ?
  - No. Go to (18).
  - Yes. Go to (3).
- ☐ (3). Is the motion typed or legibly handwritten?
  - Has defendant filed a motion along with a copy and served the prosecutor?
  - Does it contain defendant's or defense counsel's verification?
  - Is it fewer than 50 pages long (unless the court allows a longer motion? (If a longer motion is allowed, the court must give prosecutor's response the same increase). Defendant may attach to the motion any affidavit, document, or evidence to support the relief requested.
  - Does it contain:
    - ☐ The name of the defendant
    - ☐ The name of the court in which the defendant was convicted and the file number of the defendant's case
    - ☐ The place where the defendant is confined, or, if not confined, the defendant's current address
    - ☐ The offenses for which the defendant was convicted and sentenced
    - ☐ The date on which the defendant was sentenced
    - ☐ Whether the defendant was convicted by a jury, by a judge without jury, or on a plea of guilty, guilty but mentally ill, or nolo contendere
