IRC section 183 and the accompanying Treasury Regulations do not provide absolute definition but serve to provide guidance in formulating the facts into a conclusion. For whatever reason, taxpayers have engaged in these activities albeit for the pleasure of a hobby or the tax benefits derived. These activities were not engaged in for the sake of deriving a profit. The examiner should use this guide during all phases of an examination where the provisions of IRC section 183 may be applicable.
