

Private Inurement and Private Benefit

- IRC Section 501(3)(3) prohibits private inurement and limits private benefit.
- Private inurement occurs when insiders receive a benefit from the nonprofit. Private inurement is ***absolutely prohibited***.
- Private benefit occurs when a private person receives a benefit from a nonprofit that is ***more than insubstantial***. Accordingly, private benefit is limited rather than absolutely prohibited. The private person or persons are not limited to persons who are insiders.
 - Private benefit does not occur when a member of the charitable class that the nonprofit is organized and operated to serve receives a benefit in the course and scope of the nonprofit's charitable purposes.
