SECOND DEGREE FELONY: jail term 2-20 years; fine up to \$10000

THIRD DEGREE FELONY: jail term 2-10 years; fine up to \$10000

CLASS A MISDEMEANOR (violate MPA, adult): fine not to exceed \$4000; jail no longer than one year

CLASS B MISDEMEANOR (baby, child): fine up to \$2000, jail up to 180 days

CLASS C MISDEMEANOR: fine up to \$500

****ALL ARE CRIMINAL****

CONTINUING MEDICAL EDUCATION (CME):

*Must have 24 hours of CME/year OR if within the preceding 36 months, the licensee becomes Board certified or recertified

*One half must be from a formal course approved by the Board (at least one hour from medical ethics and/or professional responsibility)

*The remaining can be self-study and/or volunteer in a medically underserved area.

*The following can be used toward CME: board certification/re-certification, CME hours from a previous licensure period (only
