Record all petty cash reimbursements and collect receipts for those reimbursements. Ensure that each receipt has the business purpose noted. Reimburse purchaser up to \$25.00 per transaction. File the original receipt and petty cash transmittal awaiting reimbursement. Complete reconciliations monthly and each time the fund is replenished. Submit the Cornell University Petty Cash reconciliation sheet (Addendum A) to the ASC to request reimbursement. Attach original receipts with the request. It is recommended that each receipt be affixed to an 8 1/2° x 11° sheet of paper for document control purposes (Addendum B). Report overages or shortages to your supervisor, and adjust funds accordingly. Submit reconcilements to the Dept. Chair or Unit Leader, supervisor, or designee for his/her review and approval. Retain copies of fund reconciliations in accordance with Cornell University Policy 4.7. Retention of University Records (6-year retention).
