Physical therapy DOES NOT include: - - The use of electricity for cauterization or other surgical purposes.

- The use of Roentgen rays or radium for diagnostic or therapeutic purposes

Physical Therapist - A person who practices or provides patient education and instruction in physical therapy and includes a physiotherapist

Individual who performs initial examination unless that PT has transferred the responsibility for the management of the patient's care to another PT and that PT agrees to the transfer
