COMPEL DISCOVERY

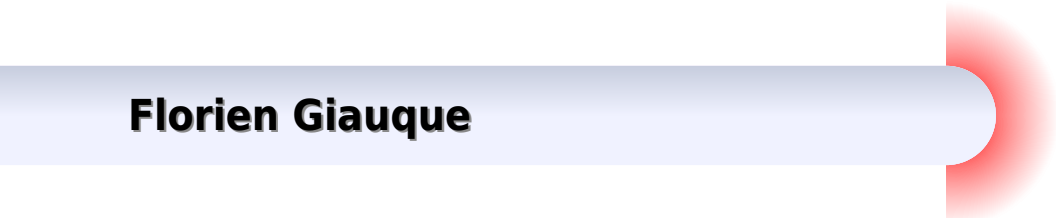
NOW COMES the Defendant, Suburban Mobility Authority for Regional Transportation a/k/a SMART, a Michigan Corporation, by and through its attorneys, ZAUSMER, KAUFMAN, AUGUST & CALDWELL, P.C., and in support of its Motion to Compel Discovery states as follows:

1. On or about July 18, 2003, Defendant requested, via Michigan Legal Copy, L.L.C., authorization to copy the records of St. John's Macomb Hospital, Crestview Dental, Dr. Morrison and Dr. Rathur with respect to Plaintiff Cheryl Hewitt.
